

PRIVACY POLICY

This Privacy Policy (hereinafter referred to as the Policy) governs the collection, use, disclosure, communication and storage of personal data of the media representatives involved in the European Combined Events Team Championships, Super League, on 6–7 July 2019 in Lutsk (hereinafter referred to as the Event).

1. Terms and Definitions

Personal data are any data or a collection of data about an individual that is identified or can be specifically identified.

A data subject is a person whose personal data are being processed.

The owner of personal data is a physical person or legal entity, which determines the purpose of personal data processing, the composition of these data and the procedures for their processing.

Processing of personal data is any action or a combination of actions, such as collection, registration, accumulation, storage, adaptation, modification, renewal, use and dissemination (distribution, implementation, communication), depersonalisation, deletion of personal data, including through the use of information (automated) systems.

Consent of a subject of personal data is a voluntary declaration of will by an individual provided he/she has been properly informed to grant permission to process his/her personal data in accordance with the purpose of processing stated in a written or any other form that allows to conclude that the permission has been granted.

Automated processing of personal data is personal data processing by means of computer technology.

Personal data dissemination is any action aimed at disclosure of personal data to an indefinite number of persons (communication of personal data) or making personal data available to an unlimited number of persons, which includes making the personal data public through mass media, placing in information and telecommunication networks or providing access to personal data in any other way.

Destruction of personal data is any action, as a result of which personal data are destroyed irrevocably so that the content of personal data in the personal data information system is unrestorable and/or the physical media, on which the personal data are stored, are destroyed.

2. General Provisions

2.1. The Policy governs any interaction between the Event organisers and media representatives related to personal data processing during the Event.

2.2. Personal data shall be processed in accordance with the law of Ukraine No. 2297-VI *On Personal Data Protection* as of 01 June 2010.

2.3. The owner of personal data is Ukrainian Athletic Association.

2.4. Personal data are stored and processed at the address: 17th Floor, Building 2, B. Hmyria Street, Kyiv.

2.5. If you want to update, access, change, block or delete your personal data, withdraw consent to personal data processing granted to the Event organiser, or if you have any comments, requests or complaints regarding your personal data that are processed by the latter, please contact the organiser at the address: 17th Floor, Building 2, B. Hmyria Street, Kyiv.

3. Consent to Personal Data Collection and Processing

3.1. Each person wishing to cover the Event as a media representative shall provide a written consent to personal data collection and processing.

3.2. Personal data of media representatives shall be collected, used, disclosed, communicated and stored in the manner and under the conditions determined by the Policy and the legislation of Ukraine.

3.3. Lack of a written consent to personal data collection and processing constitutes a ground for refusing to register the person as a media representative.

4. Personal Data Processing, Storage and Protection

4.1. Personal data shall be processed, stored and protected exclusively for the purpose of organisation and conduct of the Event.

4.2. Personal data shall be verified in order to ensure security of the Event, comply with the legislation of Ukraine and combat terrorism.

4.3. The Event organisers may use automated means for personal data processing.

4.4. Personal data shall be stored on paper and electronic media of the Event organisers and/or contracting parties. The Event organisers guarantee that all their contracting parties and partners strictly comply herewith regarding personal data protection and do not use personal data for any purposes other than specified herein.

4.5. The Event organisers shall take all the necessary organisational, legal and technical measures to protect personal data.

4.6. Personal data shall be stored for 12 months from the date of the Event.

4.7. Any personal data collected and processed hereunder may be provided to third parties provided that: (1) you consent to their disclosure; (2) personal data are anonymous; (3) personal data are subject to disclosure in accordance with the legislation of Ukraine.

4.6. The Event organisers guarantee that the provided personal data shall be used only for the purposes and over the period of time provided herein.

4.7. The Event organisers ensure personal data protection by limiting the number of people who have access to them.

5. Disclosure of Personal Data

5.1. Your personal data shall only be disclosed in accordance with the Law of Ukraine *On Personal Data Protection*, pursuant to a court order or a request of law enforcement agencies.

5.2. Personal data may be disclosed in order to ensure national security, protect the rights and legitimate interests of the Event organisers and third parties.

6. Final Provisions

6.1. The Policy is subject to change at any time during the Event.

6.2. The legislation applied for these purposes consists of the laws and regulations of Ukraine.

6.3. Any differences and disputes arising hereunder are resolved in court.

6.4. The Policy is drawn up in English and Ukrainian. In case of disagreement, the Ukrainian version of the document shall prevail.
